

GAMING CARD WAITLIST CAMPAIGN COMPETITION TERMS AND CONDITIONS

Last updated: 27 March 2026

1. COMPETITION OVERVIEW

1.1 The Gaming Card Waitlist Giveaway ("the Competition") is open to all individuals who join the Gaming Card waitlist via **www.nedbankesportsarena.co.za/gaming-card**.

1.2 By joining the waitlist, participants automatically receive one (1) entry into the monthly prize draw.

2. COMPETITION PERIOD AND PRIZE STRUCTURE

2.1 The Competition runs for four (4) months with monthly prize draws.

2.2 Total Prize Pool: R100,000 worth of prize value.

2.3 Monthly Prize Pool: R25,000 worth of prize value per month

2.4 Prizes may include, but are not limited to: vouchers, gaming vouchers, gaming merchandise, tournament access, and other gaming-related rewards. The specific prizes for each monthly draw will be determined at the Promoter's discretion.

2.5 Monthly draw dates are as follows: 19 December 2025, 31 January 2026, and 28 February 2026.

2.6 Winners will be selected through a random draw from all eligible entries received from the start of the competition.

3. ENTRY MECHANISM

3.1 Automatic Entry: All participants who join the Gaming Card waitlist receive one (1) automatic entry into all monthly prize draws for the duration of the Competition.

3.2 Entries are valid for all remaining monthly draws.

4. ELIGIBILITY REQUIREMENTS

4.1 The Competition is open to South African residents aged 16 years or older.

4.2 Participants must:

- Join the Gaming Card waitlist via Nedbank Esports Arena
 - Provide accurate and verifiable contact information including email and mobile numbers where required.
 - Maintain an active email address for winner notifications
- 4.3 Employees of Nedbank, Mastercard, agencies involved in the development or execution of this campaign, and their immediate family members are not eligible to participate

4.4 Winners of a monthly prize draw are not eligible to win in subsequent monthly draws but will remain on the waitlist for the Gaming Card.

5. GENERAL TERMS AND CONDITIONS

5.1 All prizes are non-transferable and may not be exchanged for cash or other goods.

5.2 Winners will be contacted via email within seven (7) business days of the monthly draw.

5.3 Winners may be required to provide additional information for prize fulfilment, including but not limited to shipping addresses, identification verification, or other details as specified by the Promoter.

- Verify the eligibility of all participants and winners
- Request proof of identity and age
- Disqualify any participant found to be engaging in fraudulent activity
- Modify or terminate the Competition at any time with reasonable notice
- Substitute prizes of equal or greater value if specified prizes become unavailable
